### **Proposed Elko Fire Service Will Go to Vote**

Electors in Elko will vote later this year on whether or not to proceed with the establishment of a new Elko Fire Protection Service. The vote will be held in conjunction with the 2011 local government elections in November.

### **Baynes Lake Official Community Plan and Zoning Bylaw**

The Board gave first and second reading to a new OCP and Zoning Bylaw for the Baynes Lake and Kragmont areas. The Bylaws are the culmination of a two-year planning process with local residents and property owners. A public hearing on the proposed bylaws will be held at 7pm, June 29<sup>th</sup> at the Community Hall in Baynes Lake.

### **Regional Parks Plan Amended to Include New Boat Launch, Agreements Signed and Fee Bylaw Introduced**

The Regional Parks Plan has been amended to include the new Yaqaxqaxlamki Boat Launch at Kooconusa. The Chair and CAO have been authorized to sign the Recreation Site Agreement with the Ministry of Forests, Land and Natural Resource Operations. Under this agreement, the RDEK will operate and maintain the Boat Launch.

The Board also adopted a new Regulation and Fee Bylaw which sets out the fees that will be charged to launch boats. The new fee structure includes a single use launch fee of \$10, seasonal \$50 launch pass for residents of Electoral Areas A, B and C, the Cities of Cranbrook, Kimberley and Fernie, and Districts of Sparwood and Elkford. The non-resident seasonal pass will be \$75 per season and applies to anyone living outside the areas listed above.

RDEK Staff will now work on a contract for the operation of the Boat Launch, which is expected to open in July.

### **Wasa Area Development Does Not Proceed**

The Board voted not to proceed with Bylaw 2282 to amend the Wasa and Area Land Use Bylaw after hearing from several delegations about concerns over the groundwater supply and the need for updated planning in the community. The bylaw amendment would have facilitated a new 47 lot residential development on Wolf Creek Road.
